APPOINTMENT OF CIVIL ENGINEERING CONSULTANT TO UNDERTAKE DESIGNS AND OVERSEE CONSTRUCTION OF **UNDERBERG ROADS PHASE 1**

1. BID INVITATION

Bids are hereby invited from suitably qualified and experienced Civil Consulting Engineers for the Design and Project Management of Project as indicated below within Dr Nkosazana Dlamini Zuma Municipality (KZN 436). The roads will be designed to COLTO Standard Specifications for Road and Bridge Works for state Road Authorities 1998 edition, Dr Nkosazana Dlamini Zuma and Department of Transport standards. The adjudication of the bids will be done in terms of the Preferential Procurement Regulations, 2011 Pertaining to Preferential Procurement Policy Framework (Act No. 5 of 2000) and will be based on the 90/10 points system. Preferential points will be awarded to Service Providers using their B-BBEE status level of contribution.

Bidders MUST score minimum of 70% on functionality before the Bid is considered for further price and preference point's evaluation.

2. COMPULSORY BRIEFING
