1 BID INVITATION

Bids are hereby invited from suitably qualified and experienced Contractors for the construction of Project as indicated on the table below within Dr Nkosazana Dlamini Zuma Municipality (KZN 436). The road will be built to COLTO Standard Specifications for Road and Bridge Works for state Road Authorities 1998, Creche and Community Hall to be built to Public works and Municipal Standards. Only bidders with a CIDB Grading as indicated on the table will be considered in the adjudication process. The adjudication of the bids will be done in terms of the Preferential procurement regulations 2011 as amended to align with new B-BBEE codes of good practice in the 2017 regulations and will be based on the 80/20 points system, points will be awarded as follows 80 – Price and 20 – BBBEE status.

These are Municipal Infrastructure Grant projects which have to address LED and EPWP requirements; therefore, contractors must show compliance of the above in their proposals.
