- The municipality will consider Veeam (onsite + cloud) backup disaster recovery solution
- The preferential bidder must have an understanding on how to read, restore, backup, transfer, import, export data when using any backup SOLUTION and VMware environment.
- Business-critical systems can be setup in a high availability mode with multiple hosts to quickly recover critical systems and data.
- The service provider must protect DR NDZ LM systems, provide current hardware and system availability for DR NDZ LM end users.
- Regular testing must be performed on key critical systems with easy access to Backed up data.
- Disaster Recovery data Centre geographic location between 100KM distance from the municipal offices.
- Support, working in collaboration with DR NDZ ICT staff during regular testing.
- Business Continuity Resiliency.
