SALE OF 7 RAIL COACHES

The Dr Nkosazana Dlamini-Zuma Municipality has in partnership with various role-players developed a Heritage Rail Tourism product running Steam Hauled Day trips from Creighton. The Municipality is intending to dispose of 7 Refurbished RAIL COACHES, which are surplus to their needs, suitable for accommodating en-suite sleeping passengers. The coaches to be sold are the "seven accommodation coaches" and do not include the Lounge, Dining and Observation Coaches which are used by the Rail Tourism Day Trip offering.

The coaches are deteriorating as a result of cable and metal theft and exposure to the elements. The coaches are costing the Municipality e.g. monthly depreciation. The coaches are not being used as was intended. This is an asset with a current demand that may not be sustained and should be disposed of while such a demand exists.

It is important to acknowledge that while the running of a luxury overnight train has proved unsuccessful for understandable reasons the concept of RAIL TOURISM as a tourist attraction is both successful and forms part of the ongoing plans of the Municipality.

By recovering all the public monies invested in the original Sisonke Stimela and redirecting the investment for the public good will be recognized as responsible guardianship.

Therefore the Municipality is seeking public comment before disposing of this asset.
