1 BID INVITATION

Only bidders with a CIDB Grading as indicated on the table will be considered in the adjudication process. The adjudication of the bids will be done in terms of the Preferential Procurement Regulations, 2011 Pertaining to Preferential Procurement Policy Frameworks Act, 2000 (Act No. 5 of 2000) and will be based on the functionality and 80/20 points system, points will be awarded as follows 80 – Price and 20 – BBBEE status.

These are Municipal Infrastructure Grant projects which have to address LED and EPWP requirements; therefore, contractors must show compliance of the above in their proposals.
