1. BID INVITATION

Bids are hereby invited from suitably qualified and experienced **Electrical Service Providers for implementation of electrification project using Turnkey Strategy (Marketing, Survey, Design, Preparation of Documentation, Project Management, implementation, monitoring and closing out)** as indicated below within Dr Nkosazana Dlamini – Zuma Municipality (KZN 436). The adjudication of the bids will be done in terms of the Preferential Procurement Regulations, 2017 Preferential points will be awarded to Service Providers using their B-BBEE status level of contribution and will be based on the Pre-qualification, Functionality and 80/20 points system.
