The successful service provider will be required to provide following services but not limited to: - Provision of preliminary designs (drawings) and final designs (drawings), conducting of engineering studies e.g Geotechnical investigation and Survey, preparation of feasibility report, preparation of bid documentation, attending of project related meetings, project monitoring during construction and preparation of monthly and close out reports.

The adjudication of the bids will be done in terms of the Preferential Procurement Regulations 2011 as amended to align with new B-BBEE codes of good Practice in the 2017 regulations and will be based on the Functionality and 80/20 points system, points will be awarded as follows 80 – Price and 20 – BBBEE status.
