Bids are hereby invited from suitably qualified and experienced Contractors for the upgrading of taxi rank project as indicated on the table below within Dr. Nkosazana Dlamini Zuma Municipality (KZN 436). The taxi rank should be upgraded to meet the Department of Transport and Dr. Nkosazana Dlamini Zuma Local Municipality Standards. Only bidders with a CIDB Grading as indicated on the table will be considered in the adjudication process. The adjudication of the bids will be done in terms of the Preferential Procurement Regulations, 2011 Pertaining to Preferential Procurement Policy Frameworks Act, 2000 (Act No. 5 of 2000) and will be based on the 80/20 points system, points will be awarded as follows 80 – Price and 20 – BBEE status.

This is a Municipal Infrastructure Grant project, which has to address LED and EPWP requirements; therefore contractors must show compliance of the above in their proposals.
