# Residents complain as taps remain dry

RESIDENTS in the rural villages of Matatiele, Magema, Outspan and Zwelitsha say that they were told that they could expect water from their taps on October 3, however, their taps are still dry.

This was after a local forum called Sibi Water Crisis said it organised several meetings with the Alfred Nzo District Municipality to make sure that residents get clean running water. The forum's spokesperson, Bongani Gugushe, said that after the meetings a team from water maintenance in the district municipality was sent to the area and they provided boreholes.

"Through engagements with the district municipality, a maintenance team was sent to the villages to fix boreholes, and they told us to expect water on October 3. To our surprise, we never received water," Gugushe said.

He added that the district municipality is not saying when they will get clean water and residents

are having to use unclean water from nearby streams, with animals getting water from the same streams. Several taps have been vandalised in the area.

He said the taps have been dry since last year.

Questions were sent to the district municipality that is responsible for the supply of water, but there was no response at the time of

KOKSTAD police responded swiftly when a local teacher's car was hijacked next to the Shayamoya Community Hall at 11.30 am on October 11.

As a result, three suspects aged 23, 27, and 32 were arrested on the same day. One suspect ran away.

which blocked their way, said SAPS spokesperson Captain Dumisani Ncongo. One of the suspects occupied the driver's seat, pushing the driver out of the way, while another suspect occupied the passenger seat and they drove away.

On the same day, police managed to arrest three suspects and the vehicle was recovered.

Ncongo said the suspects appeared in the Kokstad Magistrate's Court on October 14 and their case was remanded to October 21 for a formal bail application.


One of the unhappy residents, Fikiswa Chiya, accused the ward councillor of removing their belongings from their houses without giving them a reason, on October 14.

"Some of our belongings were damaged. We occupied 50 houses that were not used, and now we are being evicted," said Chiya.

Councillor Mzizi denied the claims, saying that there was an agreement reached with some residents to leave the houses in order to allow others to

"The houses were built to be accommodated by residents whose RDP houses are under renovation, however, the houses were illegally occupied. Now the municipality is in the process of letting the right people in,' said Mzizi.

The South African Communist Party Umzimkhulu Sub District secretary Madoda Ndzelu accused Mzizi of dividing the community. In response to the allegations, Mzizi said the SACP is personally fighting her and is against the development that she is bringing to the

DETECTIVES who deal with the Family Violence, Child Protection and Sexual Offences Unit in KwaZulu-Natal secured 35 terms of life imprisonment as well as 621 years imprisonment, for criminals accused of sex-related cases

in the month of September.  $They worked \, tir\bar{e} less ly \, to \, ensure \, that \,$ those accused of the shocking crimes were successfully prosecuted. With sexual-offence cases being reported across the province, the detectives were faced with cases where the accused ranged between six and 60 years old, while the victims ranged between seven and 58 years old

The highlight of their investigations was the conviction of serial rapist Moses Mavila (27), who received 32 terms of life imprisonment for terrorising women in the Westville area.

During September, police arrested 242 suspects for sexual-offence cases, and 23 cases were finalised, with the accused being incarcerated for their

The accused in these matters were convicted for crimes such as rape, sexu-

al assault, robbery, assault with intent to do grievous bodily harm and attempt-

The KwaZulu-Natal Provincial Commissioner, Lieutenant General Khombinkosi Jula, commended the detectives for their hard work in securing these convictions.

"These stiff sentences send a clear message to those who abuse women and children that we remain committed to fighting gender-based crime on all fronts," he said.

# SAPS investigate Kokstad house robberies

AN investigation into a house robbery was established at Kokstad Police Station after three suspects forcefully entered a house in Horseshoe while a 37-year-old man was asleep on October 10.

The suspects instructed the man to drive with them to Shayamoya. Along the way, the suspect who was driving the vehicle lost control of the vehicle and the three suspects ran

SAPS spokesperson Captain Dumisani Ncongo said the incident occurred between 11 pmon October 10, and 1.30 am the next day.

He said no arrests have been made. In a separate case, a 35-year-old suspect was arrested for house robbery in Bhongweni.

"The house owner was watching television when a suspect forcefully entered the house at 9 pm. The suspect demanded cellphones and money," said Ncongo.

The suspect was arrested and he appeared in the Kokstad Magistrate's Court on October 14 for house robbery.
